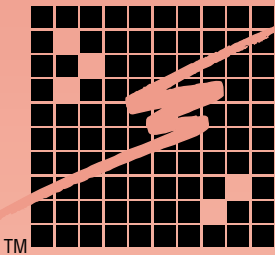

DIRECTIONS

USE INFORMATION:

For use on automobile & equipment parts, tools and other surfaces.

DIRECTIONS:

Shake can well before use. Attach extension tube (optional) for tight spaces or to focus on a small area. Remove gross soils with an scraper, brush, cloth, etc. Hold can 6-8 inches away from surface to be cleaned. Spray liberally until desired result is achieved.

DANGER

Contains gas under pressure; may explode if heated. Extremely flammable aerosol. May be fatal if swallowed and enters airways. May cause damage to organs through prolonged or repeated exposure. Causes damage to organs. Suspected of damaging fertility or the unborn child. May cause cancer. May cause genetic defects. Causes skin irritation. Causes serious eye irritation. Harmful if swallowed. Harmful in contact with skin. Harmful if inhaled.

Prevention

Wear eye / face protection. Pressurized container: Do not pierce or burn, even after use. Do not spray on an open flame or other ignition source. Keep away from heat / sparks / open flames / hot surfaces. No smoking. Do not breathe dust / fume / gas / mist / vapors / spray. Use only outdoors or in a well-ventilated area. Do not eat, drink or smoke when using this product. Wash face, hands and any exposed skin thoroughly after handling. Use personal protective equipment as required.

RESPONSE

Specific treatment (see SDS). IF exposed: Call a POISON CENTER or doctor/physician. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice / attention. IF ON SKIN: Wash with plenty of soap and water. Call a POISON CENTER or doctor / physician if you feel unwell. If skin irritation occurs: Get medical advice / attention. Take off contaminated clothing and wash before reuse. IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor / physician if you feel unwell. IF INGESTED: Rinse mouth. IF SWALLOWED: Immediately call a POISON CENTER or doctor / physician. Do NOT induce vomiting.

Storage

Store locked up. Protect from sunlight. Store in a well-ventilated place. Do not expose to temperatures exceeding 122°F (50°C).

Disposal

Dispose of contents / container to an approved waste disposal plant.
