DIRECTIONS FOR USE:

DISINFECTION, DEODORIZATION AND CLEANING: Shake can before using. Hold container 6 to 8 inches from surface to be treated. Spray area until it is covered with white foam. Allow foam to penetrate and remain wet for 10 minutes. No scrubbing is necessary. Wipe off with a clean cloth, mop or sponge. The product will not leave grit or soap scum. For heavily soiled areas, a pre-cleaning step is required before treatment. When used in food processing establishments, cover or remove all food and packaging materials, remove all gross soils, saturate all surfaces with the spray product, scrub to loosen all soils, allow to soak for 10 minutes, thoroughly rinse all wetted and cleaned surfaces with potable water.
